**New York State Industries for the Disabled, Inc. (NYSID) Certification**

Pursuant to Article XI, § 162 of the New York State Finance Law (“SFL”), an application may be made for partnering relationships between private vendors (“Corporate Partners”) and preferred sources (“Member Agencies”). New York State Industries for the Disabled, Inc. (“NYSID”) submits this application to the New York State Education Department (“SED”) for approval of a partnering relationship between the identified NYSID Member Agency and proposed Corporate Partner for the purpose of providing commodities or services for sale to the State agency, public authority, public benefit corporation, or political subdivision (the “Government Entity”) identified above pursuant to SFL § 162.

NYSID will take affirmative steps to compel its respective Member Agency and the proposed Corporate Partner applying for this corporate partnership to maintain compliance with the CPBA and the requirements of the State Finance Law and federal law, as follows:

- i. The majority of the work will be performed by individuals with significant disabilities, as defined in the Rehabilitation Act of 1973, as amended by the Workforce Innovation and Opportunity Act of 2014;
- ii. Bona fide long-term employment opportunities for persons with significant disabilities will be provided;
- iii. Solicited commodities or services are offered at a price less than the price that otherwise would be charged by a preferred source.

As such, NYSID certifies and affirms that it will monitor and take affirmative steps to compel the compliance of its Member Agency and Corporate Partner, and report to SED and the Government Entity any instances of non-compliance with the above corporate partnership requirements, as well as any corrective actions taken by its Member Agency and Corporate Partner to maintain the overall integrity of the NYSID preferred source corporate partnership program.
